Village of Loomis Regular Board Meeting Minutes December 9, 2024 7:00PM

REGULAR MEETING

The Village Board of Trustees of the Village of Loomis held a Regular Meeting on December 9, 2024, at the Loomis Community Building. Notice of the meeting was published in the Holdrege Daily Citizen and posted at the Loomis Post Office, Loomis Village Office and First State Bank of Loomis. The agenda for said meeting was kept continuously at the office of the Village Clerk.

Chairman Keith Fagot opened the meeting at 7:00PM.

Chairman Fagot explained that the meeting would be conducted under the Open Meeting Laws of the State of Nebraska and that a copy of those laws was placed on the counter of the meeting room for anyone who wished to read them.

Ben moved and Max seconded to approve the previous month's regular meeting minutes. Voting Aye: Don, Keith, Melanie, Max, Ben. Voting Nay: None. Motion passed 5/0.

Public comment was open to the public. One comment explained that Christmas on Main Street was a success.

A representative was present to represent a resident concerning nuisance violations. After the discussion, the representative was instructed to inform the necessary persons that the Village ordinances must be followed.

The increase in garbage rates was discussed. The rates will increase by 2% and the Village Clerk will set up the new charges.

The following Resolution was introduced by Chairman Fagot.

RESOLUTION 2024-12-09 VILLAGE OF LOOMIS LOOMIS, NEBRASKA

WHEREAS, The Mayor and Village Board realize the water rates of the Village Of Loomis, Nebraska must be adjusted from time to time; and

WHEREAS, the Mayor and Village Board of the Village of Loomis realize it is in the best interest of the Village of Loomis and its citizens to maintain the municipal water system in a solvent position; and

WHEREAS, the Mayor and Village Board of the Village of Loomis have reviewed the current rates and have found that the unlimited use water fee has not be adjusted in more the 12 years; and

WHEREAS, the Village of Loomis is funding the bond issues for the recent installation of the new well as well as recent repairs to the water main system from the utility fund; and

NOW, THEREFORE, BE IT RESOLVED, BY THE VILLAGE BOARD OF THE VILLAGE OF LOOMIS, NEBRASKA:

The current rate for water of \$17.94 per month be increased by \$10.00 per month, for a new rate of \$27.94 per month for unlimited water usage, effective February 1, 2025, for single house users and that the new rate will be calculated accordingly as currently in effect for commercial and school sites and the rate shall be reviewed annually to ascertain the need for further increases. Motion by Ben and second by Keith to adopt Resolution 2024-12-09 as presented. Voting YES: Max, Melanie, Ben, Keith, Don. Voting NO: None. The motion carried 5/0.
